## Monitoring Trash, TMDLs and Efforts Towards Compliance

Trash has been one of the major problems in most urbanized areas. Significant impacts include nuisance, public health and endangerment to aquatic life. Los Angeles Regional Water Qaulity Control Board initiated the development of trash TMDL in year 2001. Up to date, more than 10 trash TMDLs were in effect which cover multiple watersheds. Responsible parties including municipalities and public agencies are making efforts to fulfill requirements specified in trash TMDLs. Monitoring is a critical component of these programs.

Eric Wu earned his Master of Engineering in Science from the Johns Hopkins University and PH.D. from University of Southern California. He has experiences with the Site Cleanup Unit, TMDL unit, and became Unit Chief of the TMDL unit in 2008. in 2011, he transferred to be the Unit Chief for Groundwater Permitting. He is also the California Licensed Professional Engineer.

In response to that need, the California Water Quality Monitoring Council is partnering with the Water Board's Surface Water Ambient Monitoring Program, the Nonpoint Source Program and the U.S. Environmental Protection Agency to launch a monthly conference call to support the activities of regional monitoring programs.

The Water Quality Monitoring Collaboration Network began as a voluntary monthly conference call that members of the monitoring community participated in and discussed topics meeting their interests. The conference call format and content varied in response to input from participants and subsequently changed to a Webinar format.
