Notes:	Kris Jones <u>presented</u> on two topics for discussion regarding the Monitoring Council's future direction—he proposed having subcommittees that focus on the Monitoring Council's Strategy and Membership, as well as the Council's Portals. Kris indicated that the Strategy and Membership Subcommittee would try to meet in January, allowing time to brief the Undersecretaries for Natural		

Resources and Environmental Protection in advance of the February 23 Council meeting; Kris suggested soliciting feedback and guidance from the agency heads, in order to ensure that the Council's updated Strategy was in line with the priorities of the two agencies. Steve Weisberg, Karen Larsen, and Taryn Ravazzini agreed to take part in the subcommittee focused on the Council's Strategy and Membership.

Kris indicated that the subcommittee focused on the Council's portals would likely meet several times to identify a path forward, reflecting on the 'lesson's learned' from the implementation of the My Water Quality portal's. He proposed including the leads from the Council's various workgroups, in addition to interested Council members. Karen Larsen suggested revisiting the initial charge of the portals, as the group reflects on how best to move forward—other's agreed. Beth Christman, Terry Fleming, Helen Fitanides, Shelly Walther, and Ray Hiemstra volunteered to take part in those discussions.

Notes:	Amye Osti demonstrated the new Estuaries Portal, which has not yet launched. The new look and feel was a dramatic departure from the look of the Council's other theme specific portals. This raised slight concerns for Steve Weisberg, who indicated that the Estuaries Portal represents a dramatic leap forward for the Council's portals; however, he indicated that the Portal Subcommittee should consider how to address the differences of the portal's (e.g., is it an issue that they look different)? Steve also encouraged the Estuaries Workgroup to develop content that focused on assessments of ecosystem health. Kris Jones indicated that several of the workgroups struggle to develop this type of content on their portals—adding that this was a common challenge for the Council's workgroups. Kris added that with regard to the Estuary Workgroup, there had been an effort to take part in the State of the San Francisco Estuary Report 2015; however, he indicated that the workgroup experienced pushback from management during this collaborative effort (e.g., coming up with assessments of estuary health). He added that though this had previously been a challenge, the workgroup could certainly try and revisit these types of assessments as they move forward. Kris

Notes:	a) The Council members were supportive of the updated format for the agenda's and meeting notes—all agreed that they should be more streamlined. b) Taryn Ravazzini introduced herself as the new Monitoring Council Co-Chair representing the Natural Resources Agency. Taryn's appointment letter, sent from the Secretary Jonathan Laird (Natural Resources) on November 27, was shared with the Council members. Karen Larsen also provided an update on the Monitoring Council Director vacancy, indicating that candidates have been interviewed and that a second round of interviews will take place in December. Karen expected that the Director position should be filled by January 1st. Kris Jones then indicated that he had recently received a promotion as an Executive Advisor (Program Manager II) working under Taryn Ravazzini, DWR Deputy Director over Special Initiatives. Kris added that in his new position he would be able to maintain his part-time duties as Monitoring Council Assistant Director. c) Chris McCready updated the Council on the upcoming workshop hosted by the California Council for Science and Technology (UC Berkeley; November 29), which will mainly focus on updates and soliciting feedback from key stakeholders. Chris indicated that an interagency team is currently working towards developing a draft strategy document and draft protocols. She indicated that she would work with Kris Jones to solicit input and feedback from the Council members when they are ready for review (January 2018).

Title of Topic:	SUPPORT FOR AN ENVIRONMENTAL FLOWS WORKGROUP UNDER THE MONITORING COUNCIL		
Purpose:	Eric Stein of the Southern California Coastal Water Research Project will provide a brief overview of efforts to develop a framework for establishing statewide environmental instream flow recommendations, followed by a discussion regarding potential Monitoring Council support for a new collaboration effort involving environmental/ecosystem flows and open data.		
Desired Outcome:	Monitoring Council endorsement of the use of the State Open Data Portal and the Council's My Water Quality website and the establishment of a new workgroup effort to facilitate knowledge transfer and data sharing on statewide environmental instream flows across agencies and programs.

Notes:	Eric Stein <u>presented</u> a brief recap of the prior presentations and discussions on this topic. Following his update, Shelly Walther asked about the placement of an Environmental Flows portal, given that the focus seems to relate (and may even overlap) with some of the Council's other portals. Kris Jones agreed, adding that as the workgroups have developed, potential collaborative opportunities (e.g., among portal efforts) have been identified; Kris indicated that the newly proposed Portal Subcommittee would try and address these concerns when they convene in January. When going over prior discussions regarding the proposed Environmental Flows Workgroup, Karen Larsen indicated that the Water Supply and Agricultural Council members had previously expressed concerns regarding including such a workgroup under the Council. Karen indicated that the concerns seemed to be regarding the workgroup's potential to influence policy. Kris Jones emphasized that the workgroup's proposed focus is on improved coordination and data sharing—not influencing policy. He added that this was detailed in Eric's prior presentations. This sentiment was mirrored by Eric Stein. After a brief discussion regarding clarifying the workgroup's objectives (e.g., making it clear the workgroup would not be working to influence policy), Steve Weisberg raised the motion to form an Environmental Flows workgroup under the Monitoring Council. Beth Christman seconded the motion. All were in favor (no objections).
