What is the California Surface Water Quality Assessments Integrated Reporting?

The Water Board's Surface Water Quality Assessment program assesses data and reports on the quality of surface waters throughout the state. This information is found in the Integrated Report. The two major components of the Integrated Report are the 305(b) condition report and the 303(d) list of impaired waters. An Integrated Report cycle occurs every two years.
