Meeting Minutes from 10/15/08

Meeting minutes were approved by the group.

Rational for Recommendations (Chris Potter, Eric Stein)

The recommendations presented in the WDP Report focused on technical needs. However, the State of the State's Wetlands Report is for a less technical audience and therefore the recommendations have been reorganized. The recommendations for this report are organized around a few needs to reach integrated monitoring. A table will need to be developed to cross reference the recommendations in the Wetlands Report and the WDP Report.

Review of Recommendations for State of the State's Wetlands Report (Craig Wilson)

There were some language changes made to each of the recommendations. The "status" section for each recommendation was changed to "status and actions" to address not only the current status but what actions are needed to accomplish the recommendation. A preamble will be added to the document by Chris. This preamble will highlight where

the state was been, where it is now, what has been learned, and where it needs to go with regard to wetland monitoring and assessment.

Eric will send around a redline document for review and comment before the document is provided to the SB1070 council. Please see this redline document for specific language changes. Larger discussions/changes are outlined below.

New Need #1

Add a new need addressing a structure for coordination among agencies. This need should focus on coordination rather establishment of new agencies or programs. Recommendations under this need would include:

- Establish a 1,2,3 Level framework for wetland monitoring in California.
- Establish a permanent state-federal workgroup to coordinate wetland monitoring and assessment. The CWMW could serve as this workgroup.

Need #2 (old Need #1)

A state agency should be responsible for maintaining wetland maps. The responsible agency will need additional resources and this should be stated in the Report. The identified agency would not necessarily be responsible for updating the maps (i.e. updates could occur outside the identified agency), but this agency would be responsible for maintaining updated versions of the maps. There should be a link between this agency and the regional data centers. The data centers could coordinate mapping. If standard file formats were used, then the regional data centers could collect map data and provide to the responsible agency for creation of a statewide map. Possible agencies discussed were: The Resources Agency, Cal EPA, and DFG. The group thought it was important for the responsible agency to already be involved in mapping. DFG was identified as the most logical agency. DFG will discuss internally to determine if it is possible for them to take this on.

<u>Need #3</u> (old Need #2)

The second recommendation under this need is focused too heavily on 404. This section also needs to address mitigation and assessment under state laws and policies. Add language regarding the need to harmonize the state and federal mitigation requirements.

Need # 4 (old Need #3)

Only small language changes were made to these recommendations.

Need #5 (old Need #4)

Add language regarding ambient monitoring and how it relates to EPA's 10 Elements Letter. Identify the need for additional funding to accomplish this recommendation. Also add language regarding possible cost savings from increased program efficiency.

Update on State Wetland Definition (Josh Collins)

The Technical Advisers Team (TAT) to the California Stream and Wetland Protection Policy Development Team has drafted a State wetland definition. The definition is based

on the Army Corps definition plus non-vegetated wetlands. The group discussed the wetlands definition and examples of habitats that would fall under wetlands versus other waters of the State. The draft document will be emailed out to the group (this document is not for distribution). The definition will be presented to the policy team on Friday November 14.

Status of State of the State's Wetlands Report (Chris Potter)

Chris is currently working on an outline for the Report and a draft is expected to be available by the end of November. Anyone interested in being on the review committee for the Resources Agency should contact Chris. The recommendations will be presented by Chris to the SB1070 Council at their November 18 meeting (Note: the recommendations were not presented to the Council on 11/18/98).

Eric will send out a redline version of the recommendations document to the group for additional comment. He will compile the changes and send out the updated document to the group. The updated version will also be provided to the SB1070 Council. Chris will email the Report outline once it is ready.
